

Pangea Charging #EVhunt Challenge (April/May2022) Terms and Conditions

- **GENERAL**

- EV Hunt challenge (“Program”, “Challenge”, or “Contest”) is being sponsored, promoted, and administered by Pangea Charging LLC (“Sponsor”)
- By entering this Contest, you agree to be bound by these Official Rules and Sponsor’s determinations regarding the Contest, which are final and binding.
- The Contest is subject to all applicable federal, state, and local laws and is void where prohibited.
- There is no purchase necessary or other cost to enter the “EV Hunt” Challenge or to win prizes.

- **ELIGIBILITY**

- To be eligible to enter the Contest you:
 - NEED to have an active and valid Instagram account
 - MUST “Follow” Pangea Charging on Instagram (LinkedIn, if applicable) prior to submitting an “EV Hunt” entry via IG Story entry.
 - Allow Pangea Charging to Follow your Instagram account.
 - Must be age thirteen (13) or older to participate.
 - All entries must be received by 5:00 PM CDT on May 17, 2022 to be eligible.
 - Contestants must Follow Pangea Charging throughout the entire Contest period, or risk their submission not counting.
- The potential winners are subject to verification of eligibility by Sponsor, which may include completing associated documentation.

- **CONTEST PERIOD**

- The Contest period begins April 18, 2022 at 12:01 AM CDT and ends May 17, 2022 at 5:00 PM CDT.

- The time clock of the computer administering this Contest is the official clock for this Contest.
- Sponsor reserves the right to shorten or lengthen the Contest Period for any reason in its sole discretion.

- **HOW TO ENTER**

- To enter the Contest, each entry must complete all steps and/or requirements of submitting an entry:
 - Follow [pangeacharging](#) account on Instagram
 - Allow Pangea Charging to Follow your Instagram account
 - Take pictures of parked Electric Vehicles (EVs) and post to your IG story.
 - Tag @PangeaCharging
 - Tag #EVhunt
 - Tag the nearest business location
- All entries must be received by 5:00 PM CDT on May 17, 2022 to be eligible.

Limit: Maximum of 100 entries per Entrant.

- **INVALID ENTRIES**

- Pictures of EVs at car dealerships do not count.
- Pictures of EVs plugged into or near an existing charger will not count.
- Pictures of EVs parked at single family homes will not count.
- Pictures of EVs parked on at single family homes will not count.

- **ENTRY QUALIFICATIONS**

- Sponsor may disqualify any Entry that, as adjudged in Sponsor's determination:
 - contains any material that is indecent, obscene, hateful, discriminatory; defamatory, slanderous, libelous, unlawful, or otherwise inappropriate;
 - is submitted in bad faith, is inappropriate, or otherwise violates these Terms and Conditions;
 - is submitted by an Entrant who is ineligible or noncompliant with these Terms and Conditions; and/or,

- is submitted by any person who tampers with or abuses any aspect of the challenge or the Pangea Charging website and its social media accounts.
- If there is a dispute about who submitted an Entry, the authorized account holder of the Instagram account used to submit an Entry will be deemed the Entrant for the Contest. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. The entrant may be required to show proof of being the authorized Instagram account holder.

- **OTHER ENTRY TERMS**

- After an Entry has been submitted, it cannot be modified in any way and Sponsor are not responsible for any delayed Entry, incomplete Entry, or Entry not received, recognized, or accepted for any reason.
- By submitting an Entry to the contest, each Entrant hereby grants Sponsor a royalty-free, irrevocable, perpetual, global, nonexclusive license to use, reproduce, modify, publish, create derivative works from, and display the information in the Entry, in whole or in part, and to incorporate it into other works, in any form, media, or technology, now known or later developed, for any purpose including for promotional and marketing purposes, including on www.pangeacharging.com or other Pangea Charging-branded websites or social platforms, or partner websites or social platforms.
- The Released Parties (defined below) do not guarantee that any Entry will be used as described in the preceding license.
- The Released Parties (defined below) are not responsible for any unauthorized use by third parties of any Entry.

- **REVIEW CRITERIA AND SELECTION OF WINNERS**

Entries will be reviewed by Sponsor on the following criteria:

- Does each entry meet the requirements listed above in “How to Enter”
- Sponsor will award 3 entrants. Winning recipients will be notified by Instagram (Live, Story, Post, or some combination) as well as other social media platforms

(Facebook, LinkedIn, Twitter) according to the timeline published at the beginning of these Terms and Conditions.

- We will make our best attempt to reach you with whatever contact information we have.
- Winners will be announced Tuesday, May 31, 2022. Winners will have 72 hours after being contacted to claim their prize. After 72 hours, Sponsor assumes the originally announced winner forfeits their prize and new winner(s) will be selected.
- All valid entries will be compiled into a list of eligible entries. Winners will be selected through a randomized raffle, in the order chosen by the Sponsor.

- **Additional Terms:**

- Sponsor, reserves the right, in their sole discretion, to conduct a brief interview with any Entrant and request for Entrant to submit additional materials relating to their Entry.
- Sponsor reserves the right to not award any prizes, if in their sole discretion, they do not receive any suitable Entries. No details of the deliberations on individual Entries will be revealed to Entrants or the public.
- Certain Entries may be featured from time to time by Sponsor during and/or after the Contest Period in Sponsor's social media pages and other channels, in the sole discretion of the Sponsor; being selected as a featured Entry is unrelated to the Review Criteria and does not guarantee selection as a Grant Recipient.
- Decisions of the Sponsor are final and may be made in its absolute and sole discretion.
- If a potential winning recipient cannot be contacted or does not respond within seventy-two (72) hours after the Sponsor's notification, it will be considered forfeited and may be awarded to an alternate recipient.

- The Released Parties make no warranties of any kind, either express or implied, including any implied warranty of merchantability or fitness for a particular purpose, with respect to any prize awarded in the Contest.

- **ODDS OF WINNING**

The odds of winning will depend on the number of eligible Entries received during the Contest Period.

- **GENERAL CONDITIONS**

● **PUBLICITY**

- By entering and participating in the Contest, each Entrant permits the use of Entrant's names and submitted content for programming, advertising, publicity, and promotional purposes in all media, now known or later created, worldwide and on the Internet, and in perpetuity by Sponsor, without compensation (unless prohibited by law) or additional consents from Entrant or any third party and without prior notice, approval, or inspection.
- Each Entrant will execute specific consent to the uses described in the previous sentence at Sponsor's request.

- **GOVERNING LAW**

Texas law governs all issues and questions concerning these Terms and Conditions and Entrant's or Sponsor's rights and obligations in connection with the Contest, and that law applies regardless of any choice-of-law principles otherwise applicable.

- **USE OF DATA**

- By participating in the Contest, each Entrant acknowledges that Sponsor may collect private or personal data about the Entrant that is submitted in the Entry (the "Private Information").
- Sponsor may collect and use the Private Information for purposes of this Program and as authorized under these Terms and Conditions.
